Include a page header (also known as the "running head") at the top of every page. For a professional paper, this includes your paper title and the page number.

# General Format // Purdue Writing Lab

APA has a few formatting guidelines for the reference list. The reference list should start on a separate page at the end of your paper. Use one-inch margins and continue the header from the rest of your paper. Title the page References, centered at the top (no bold, italics, quotation marks, etc.).

APA Format Citation A citation is a reference to the used source material in the paper. The In-text is the reference that is added within the content and it is followed by a full citation in the references list. Different referencing and paper styles have different citation formats and styles.

APA style dictates that brackets should directly surround their content without spaces (e.g., [bracketed content] should look like this). When possible, include the year, month, and date in references. If the month and date are not available, use the year of publication.

Note: All citations should be double spaced and have a hanging indent in a Reference List. A "hanging indent" means that each subsequent line after the first line of your citation should be indented by 0.5 inches. # Citing a Book in APA | Citation Machine

For a narrative citation, include the author and year in the sentence and then place the page number or other location information in parentheses after the quotation. If the quotation precedes the narrative citation, put the page number or location information after the year and a comma.

The in-text citation is written inside a parenthesis with the last name of the author and year, separated by a comma. (Santos, 2010) If the name of the author is included within the text, only the year is written inside the parenthesis. Santos (2010)
