Note: If the article is printed on discontinuous pages, list all of the page numbers/ranges and separate them with a comma. (e.g., pp. C2, C4, C7-9.) Newspaper Citation Example:

In-Text Citations: Citations are placed in the context of discussion using the author ' s last name and date of publication. When a work has no identified author, cite in text the first few words of the article title using double quotation marks, " headline-style" capitalization, and the year. (" Barcelona to Ban Burqa, " 2010)

In-text citations are brief references in the running text that direct readers to the full reference entry at the end of the paper. You include them every time you quote or paraphrase someone else ' s ideas or words. An APA in-text citation consists of the author ' s last name and the year of publication (also known as the author-date system).
